### Guide to the SoliTicketFund application (doesn't need to be printed out)

The SoliTicketFund is a solidarity fund from which students with special needs can be supported in financing their studies by the student body of the HNEE through a contribution to the semester ticket fee.

#### Where and how to submit?

- applications must be submitted in printed form and addressed to the AStA of the HNE (postal mail/delivery at the AStA office/ drop in the mailbox of the HNE mail office)
- > The deadline is the arrival of the application documents at the HNE

### **Application deadlines**

summer semester: 01.03. – 30.04. winter semester: 01.09. – 31.10.

Applications submitted after this deadline can no longer be considered!!!

#### Further information on the calculation of indigence

The following maximum amounts are included in the calculation:

- the maximum disposable income after deduction of eligible expenses must not exceed € 427.00
- the monthly income for applicants under the age of 25 years must not exceed € 718,67, from the age of 25 years € 832,67, from the age of 30 years € 907,67, resp.
- (with child/ren it increases by: € 283 (0-5 years), € 341,50 (6-11 years), € 418,50 (12-17 years)
- a maximum of € 325 rental costs (incl. operating and service charges) is credited (the allowance doubles to 650 €/month for applicants with child/ren)
- the amount of the protected assets for applicants under the age of 25 is € 1.841, resp. from the age of 25 years € 2.059, resp. from the age of 30 years € 2.219
   (with child/ren it increases by € 150 per child up to 18 years and year of age)

(for the maximum amounts, the AStA bases its calculations on the current amounts of the BAföG rates, the minimum child support, the semester fee and the ticket fee)

### **Explanation of the calculation**

For calculation purposes, all relevant income of the applicant is determined based on the information in the tables above. From the sum of your income, the sum of all costs from the information provided in the tables is deducted (of course only if they are paid by yourself). **All applicants are held to disclose their income and financial circumstances truthfully.** 

Applicants who have assets in **blocked accounts**, of which only a certain maximum amount is available each month, please indicate this monthly rate under "other income".

Please note, that some sections of the application form might not necessarily be applicable for international exchange students.
